

## ASSIGNMENT OF RIGHT-OF-WAY CHECKLIST

To be used for the transfer of any Right-of-Way from one company to another. Four (4) executed originals must be submitted and the form must be complete as to the following:

- A. Company ROW number (or DOE Invoice number)
- B. Previous Grant of Right-of-Way date
- C. Previous Grant of Right-of-Way Grantee
- D. Acreage covered by Grant of Right-of-Way
- E. ROW Name, O&G Lease Number, Legal Description, and Footage/Width/Acreage
- F. Assignee Name and Address along with ALL or PARTIAL assignment checkbox
- G. Tribal Invoice, Project Name, and Tribal Resolution Numbers
- H. Assignor and Assignee Acceptance signature blocks
- I. Acknowledgment of Assignor
- J. Acknowledgment of Assignee
- K. Approval by SUIT Chairman and BIA Superintendent will be handled by the SUIT Department of Energy Land Team

All such Assignments of Right-of-Way must be submitted to the Southern Ute Indian Tribe, Department of Energy, PO Box 1500, Ignacio, CO 81137, together with copies of the fees for administrative and filing, to wit:

The documents will be reviewed by the Southern Ute Indian Tribe Department of Energy Land team for accuracy prior to Tribal Chairman approval. The documents will then be transmitted to the BIA for processing and approval.

Upon final BIA approval of the assignment, one (1) copy will be returned to the newly assigned company. A copy will only be transmitted upon the request to the assignor company. A total of four (4) original signed copies, must be submitted for each desired transaction, one (1) original of the Evidence of Authority is necessary. If the assignee or assignor company desires additional executed "originals" same should be submitted to the BIA with appropriate instructions.
